CYC ID cards are available online (www.cycstl.net) and kids should order two when they order. Open/Closed team structure will be voted on in May. Important dates- Registration sessions: 4/29 6-9pm; 5/16 9-1pm. Soccer camp: 7/12-7/15. Evaluations: 7/19-7/22. All info on website.
- Soccer Tournament (C. Berra) –Dates for 2010 tournament are 08/20-22 and 08/27-29. Ongoing meetings about Fenton Park fields. Fenton Athletic Association fields will be available for use.
